## <u>\*\*\*\*\* County Resolution to Advise AGAINST The Use of Genetic Biologic</u> <u>"Vaccine" Platform Technology On the Child Vaccine Schedule Until</u> <u>Forensics Investigation, Idaho Health Audit, and Transparent and Accurate</u> <u>Informed Consent</u>

**WHEREAS** Idaho residents have been injured by the Genetic Biologic "COVID-19 Vaccine" platform technology, making it more injurious than any other vaccine technology in US history. As of November 3, 2023, The State of Idaho recorded at least 30 deaths, 103 permanent disabilities and 33 cases of myocarditis (2 of which are children, 6-17 years old).

Also as of November 3, 2023, The Centers for Disease Control (CDC) Vaccine Adverse Event Reporting System (VAERS), a database that holds under reported numbers, shows death, disability, and adverse events attributed to these shots since their release in 2021:

- More than 18,000 US deaths and 17,747 US reports of permanent disability.
- Total reports, including some from other countries, show 36,726 deaths and over 68, 819 permanently disabled, 27,832 cases of myocarditis/pericarditis, 21,155 heart attacks, and 5,071 miscarriages. [1-8,13,16-23]

WHEREAS, Idahoans have no fair recourse for injury due to these products because: [39]

- These COVID-19 genetic vaccine products have been unlawfully and unconstitutionally classified as lawful "Medical Countermeasures" and "Medical Products" during a Public Health Emergency and PREP Act and;
- Fraudulently represented as "safe and effective" and fully "licensed and approved" even when they are specifically "adulterated and misbranded" and;
- Their manufacturers, marketers, distributors and administrators unlawfully protected from all liability even for fraud, according to amendments to the US FD & C regulations 21 CFR 360 bbb-3a.

**WHEREAS** the mRNA and adenoviral vector genetic platform technology shots should be scrutinized and investigated due to the egregious number (all attributed to these shots) of adverse events, disabilities, and deaths to adults and children (including children in the womb), increasing rates of miscarriage and stillbirth, and adverse affects on women's' reproductive systems, including menstruation and fertility. WHEREAS multiple labs have demonstrated that both Pfizer and Moderna have engaged in misbranding, misrepresentation and adulteration of the COVID-19 genetic vaccines. These actions violate Consumer Product and Medical Product Safety standards for marketing, selling and distributing substandard, untested noncGMP (current Good Manufacturing Practice) contaminated products. Said manufacturers also employed substandard and under-powered clinical trials with formulations not representative of what was given to the public, which again violates Consumer Product Protection statutes and informed consent as well as multiple other laws that regulate pharmaceutical safety in the State of Idaho. **WHEREAS** the mRNA technology shots are adulterated with over a thousand times the allowable level of DNA from the DNA plasmids used to make the shots in <u>E. Coli</u> bacteria and this contaminating DNA has been found to make up to 35% of the genetic material in the shots. [9,11,12,21-23,25,34-38]

<u>Plasmid definition</u> (NIH): A plasmid is a small circular double stranded DNA molecule found in bacteria and some other microscopic organisms. Plasmids are physically separate from chromosomal DNA and replicate independently.

**WHEREAS** SV40 virus has been associated with tumors and cancer in animals and humans. All Pfizer mRNA shots examined have multiple non-disclosed DNA sequences from the oncogenic virus  $\underline{SV40}$ , including elements that: [7,9,10,17,19,21-23,34]

- Direct the SV40 DNA and viral spike DNA to the nucleus of human cells and;
- Allow this DNA to be incorporated and integrated into human DNA and expressed in human cells as well as in bacterial cells in the human host.

**WHEREAS** due to contamination and adulteration with bacterial plasmids, contamination with <u>E. Coli</u> bacterial proteins called "endotoxins" probably exists in the shots. Endotoxins can cause anaphylaxis, auto-immune reactions, and sepsis in the recipients. The DNA plasmids were designed to infect <u>E. Coli</u>, which is present in the human gut. If any of the plasmids are intact or revert, they could transfect gut bacteria and cause the bacteria to continually produce spike protein with no natural way to stop the production without harming the human host's microbiome. [9,11,14,17,18,20-24,35]

Endotoxin definition (NIH): Endotoxins (lipopolysaccharides, LPS) are pathogenic agents of Gram-negative bacteria (such as E. coli), implicated in the development of Gram-negative shock. [35]

WHEREAS the mRNA in the shots is also broken and degraded and is being mistranslated (due to frame shift mutations). This is producing multiple proteins or pieces of proteins (other than the viral spike protein) without informed consent. This production can cause auto-immune disease and cancers. Contamination, adulteration and degradation of the mRNA genetic sequence can lead to changing our God-given DNA. It can turn off genes that we need, such as those that fight cancer, and these genetic changes can be passed on to our children. The material in

the genetic vaccines also can shed through bodily secretions and transfect through fluids and contact, as well as through milk of a mother, including cow's milk. [7-10, 12,14-24]

Transfect definition (NIH): Transfection is a process by which foreign nucleic acids are delivered into a eukaryotic cell to modify the host cell's genetic makeup. (Eukaryotic cells contain visibly evident membrane-bound nuclei and organelles, which are like tiny organs within a cell. All animals, plants, fungi, and many unicellular organisms are eukaryotes.) [36]

**THEREFORE** \*\*\*\*\* County of Idaho declares that we value the health and lives of our children and recommend AGAINST any administration of the genetic "vaccines" or gene therapies, in any modality, to be administered to children under 18 in our county. We recommend they be removed from the child vaccine schedule in our county, and in the state of Idaho, until a forensics investigation and a health audit of Idaho can be administered by qualified agents, as well as until transparent and accurate informed consent can be given to parents and families.

**THEREFORE** \*\*\*\*\* County of Idaho supports legislation that investigates, or requires informed consent, that may recall, or may create corporate liability for products that use mRNA, DNA, or any genetic technology directly for human pharmacological use, or secondarily for human consumption, through the use of genetic vaccines in livestock, or use regarding any agricultural products that may adversely affect human health, animal health, or the food supply thereof.

**THEREFORE** \*\*\*\*\* County of Idaho supports <u>The Idaho State Statute 18-3323</u> <u>Bioweapons Law</u> with specific emphasis to section 18-3323 (4) (a, b, c, and d).

**THEREFORE** \*\*\*\*\* County of Idaho supports the Definition of Vaccines from Idaho Code 41-6002(8): "Vaccine" means any preparations of killed microorganisms, living attenuated organisms or living fully virulent organisms that are approved by the federal Food and Drug Administration (FDA) and recommended by the federal Advisory Committee on Immunization Practices (ACIP) of the Centers for Disease Control and Prevention (CDC). **THEREFORE** \*\*\*\*\* County of Idaho supports legislation that requires informed consent, transparency, and labeling of any proposed product, including imported food supply or pharmacological products, that use mRNA, DNA, LNP (lipid nanoparticle), or any genetic technology for human pharmacological use or food consumption, or use regarding any livestock or agricultural products.

**THEREFORE** \*\*\*\*\* County of Idaho supports legislation that prohibits mandates, local, state, national, or global, regarding forced medical procedures or vaccinations in any modality.

**THEREFORE** \*\*\*\*\* County of Idaho supports life affirming legislation and laws and declare that Idaho adults and children, including the unborn, have the right to normal cell growth.
