

## Ideas To Approach Your Community's Lesser Magistrates

1. **Find Your County Commissioner Website.** Look for the names of your county commissioners and clerk, meeting times, agendas, and contact numbers.
2. **Call The County Clerk:** Ask how to get on the board of commissioners meeting agenda and whether others can join the meeting via ZOOM.
  1. The clerk will explain how to get on the agenda, and typically will offer you 3-15 minutes to speak.
  2. If you need more time, such as for a presentation from science, medical, or other subject matter experts, ask how to get 30 minutes or more for a very important issue.
    - Explain that you wish to discuss the multiple adverse effects of the genetic COVID shot to your community, friends and family, and that the shot is on the childhood vaccine schedule.
    - Ask to have subject matter experts share with your commissioners ("lesser magistrates") the dangers of contaminated genetic shots. Sometimes that will be enough information; alternately, the clerk may ask you to reach out to the commissioner chair for permission to be on the agenda for a longer presentation.
    - Ask whether the commissioners simply want to watch a video of the presentation or have a group of subject matter experts present on ZOOM (if available).
    - Ask us for help (see contacts below) getting presenters, no matter how rural or urban the county. We the People 50 (<https://wethepeople50.com/>) can offer subject matter experts, but please allow a few weeks to put your meeting on our schedule and line up testimony.
3. **Before the Meeting:** Prepare a short speech, timed and practiced to fit in less than 4 minutes, so you can stand strong in front of the board and a possible crowd.
4. **During the Meeting:** Give your speech. Present a resolution or action item letter for their team to consider, sign, and send to your Attorney General, Governor, etc. This may take two visits to your board: first to educate, second to present your resolution or action letter for their signature.
5. **Other People to Approach:** Consider your local state legislators, Attorney General, Governor, sheriff, health district boards, school boards, and US legislators. Simply call and ask how to meet with them. NOTE: Legislative aides at a US legislator's office are the workers, researchers, and opinion drivers for your US Rep or Senator. Do take time to connect and share your valuable information with them.
6. **More Tips & Contact Info:**
  - Be sincere, polite, and have no fear. The territory you approach is often opposition or at best neutral territory. Prayer, having a friend in the room as moral support, and putting on the whole armor of God will be helpful.
